MINISTER'S SERVICES

Rev. Deshae Lott offers the following services to group participants:

- Small group meetings
- Prayer service
- Spiritual counseling

CMMS Deshae Lott Ministries Inc is designed for adult spiritual education.

Individual courses can last as little as two weeks or as long as six or more months. Each course requires a commitment to meet with the group and/or to follow along at the group pace but from remote locations. Post-meeting email messages inform participants on the basics of what transpires during the meeting as well as what to read and do to prepare for the next meeting. Some past meetings were recorded, and a copy of these recordings can be requested by active participants.

Counseling is available by appointment for a single visit that deals with a particular issue of concern for the counselee.

There is no fee for CMMS ministerial services.

HISTORY AND BACKGROUND

The Christian Mystics & Metaphysicians Society was founded in 1990 by the Reverends Mary and Gil Saurer as a spiritual support group for individuals who experience an ongoing sense of the divine presence within, practice abstract reasoning and apply abstract ideas to practical living, and/or have

had a direct encounter with God through a vision or abstract creative ideas or a sudden influx of light producing revelation. The participants discuss, study, and practice spiritual ideas, believing spiritual understanding is vital to soul evolution and that understanding emerges more rapidly through study of how the universal laws operate in the mind as well as in other fields of energy. After over 15 years of study with Mary Saurer Smith, Deshae Lott was ordained as a minister on August 4, 2006. Ever since then Deshae has continued her studies with her spiritual mentor Mary.

PURPOSE

To serve as an inspiration, influence, and guide to individuals who are seeking an uplifting path in their search for greater enlightenment

MISSION

To assist and encourage people in their search and discovery of greater spiritual realization through small discussion or study groups, meditation groups, and individual spiritual guidance or counseling

BELIEFS

We believe that the study and practice of both mysticism and metaphysics are fundamental to a balanced development process of increasing enlightenment on every spiritual path. We believe that the Master Teacher Jesus taught foundation principles of both mysticism and metaphysics as a unified path to complete enlightenment and beyond.

PROCESSES AND RESULTS

- Practice transcendental meditation daily as a private acceptance of God's presence; you increase your awareness of God and love for God and realization of your own divinity; this results in inner peace and agape.
- Keep your mind healthy and productive through observation and study of natural laws and contemplation of their application; you increase your understanding of how metaphysical laws apply to all action (internal and external) and practice applying your understanding; this results in self-esteem and enthusiasm for living.
- Emulate the nature of God as much as you comfortably can; perfect your character by creating your own standard of behavior and honoring it both inwardly (thinking/feeling/attitude) and outwardly (speech, choice, response, behavior); upgrade that standard or "inner program" as you find errors in it; make a habit of being a living expression of your new standard; this is being true to yourself/having integrity as you evolve; design your life style to offer the greatest potential for being true to yourself; break that habit when you desire to change your lifestyle; this results in progressive character development.
- Honor God's plan by seeking enlightenment through meditation, study, contemplation and application as long as there is more to know and become; study the nature of all that is good; this results in

revelation upon revelation, realization upon realization and expansion of divine knowledge in you.

- Pray to God frequently as a creative expression of partnership with God; contribute to God's divine plan by choosing to continue your individual soul evolution; this results in your greatest contribution to life and all that is in it.
- Live in a way that is true to yourself and true to what you understand of God's expectation of you; this results in self-approval and harmony with all that is compatible with you.

The progressive transformation process is sometimes painful and sometimes ecstatic, but the end result, absolute enlightenment, fulfills all your abstract desires and produces an inner stream of happiness that cannot be lost or forgotten, regardless of your experiences in this world or another. .

OUTREACH PROGRAM

SCHOLARSHIPS

We offer scholarships to people with physical disabilities pursuing education beyond bachelor's degrees. Few existing scholarships offer financial support for people with disabilities in their pursuit for certification and degrees beyond the bachelor's level. Since students with disabilities face extra expenses related to personal care that other

students do not, the scholarships can help severely disabled scholars defray such costs.

QUALITY-OF-LIFE GRANTS

We offer quality-of-life grants for people with severe physical disabilities. The amounts offered for grants is \$250 to \$500 unless funds can go directly to medical providers or to a special needs trusts existing on behalf of the applicant; such limits are otherwise necessary to avoid jeopardizing benefits and services, especially health insurance, that people currently receive or are on wait-lists to receive.
